- 1.2 The bid/offer is to be quoted for full quantity mentioned in this document as per Annexure II. Part quantity will not be accepted.
- 1.3 The items for which quotations have been submitted must be in accordance with the specifications given in Annexure II.
- 1.4 The offer shall be valid up to 90 days from the date of opening of EOI bid.
- 1.5 The tender is liable to be rejected if complete information is not given therein or if the particulars and date (if any) asked for in the scheduled tender are not fully filled in. Particular attention must be paid to the satisfactorily work/delivery completion and also to the particulars referred to in the conditions of this tender notice and purchase order.
- 1.6 The tender not complying with the terms & conditions mentioned in this tender are liable to be rejected at the sole discretion of IITRAM without any further reference / communication.
- 1.7 The order placed shall be non-transferable.
- 1.8 IITRAM reserves the right to choose, accept or reject any or all requests/deviations/offers, in full or part and also reserves the right to reduce or increase the quantity and split/cancel the order at any stage.
- 1.9 The bidder has to submit photocopies of following documents along with duly signed & stamped manner:

- 1.15 All the supplied material should be approved standard quality. Prior approval of IITRAM's authority must be taken about the color, fabric etc. to be used for the requested item(s). In the event of not supplying appropriate quality material in time (especially cloths etc.), IITRAM will replace the same at the cost of successful bidder and levy penalty up to @20% of the total order value.
- 1.16 The quantities, requirements and specifications mentioned in this tender notice are approximate and may vary as per requirement and few items may be deleted / added / modified by IITRAM, if needed.
- 1.17 The tender/bid will be opened on 12.07.2024, 04:30 PM at IITRAM Ahmedabad Premises. No separate information shall be given to individual bidders.
 - a) The bidders or their authorized representative may also be present at their own expenses during the opening of the bid/ offer, if they desire so. The required technical specifications for the cited item(s) is mentioned in Annexure-II.
 - b) The tender committee nominated by IITRAM reserves the right to select or reject any or all of the item(s) mentioned above without assigning any reasons.
- 1.18 Any effort by a bidder to influence IITRAM's tender evaluation, tender comparison or contract/order award decisions may result in the rejection of the bidder's tender and forfeiture of the bidder's EMD.
- 1.19 After opening of bids, information relating to the examination, clarification, evaluation and comparisons of bids and recommendations concerning the award of contract shall not be disclosed to bidders or other persons not officially concerned with such process.
