- 1.10 The quotations will be opened on **08.01.2024, at 02:30 PM** at IITRAM Ahmedabad Premises. No separate information shall be given to individual bidders.
 - The bidders or their authorized representative may remain present during the opening of the quotations, if they desire so, at their own expenses.
- 1.11 Incomplete quotations, amendments and additions to quotations after opening or late quotations are liable to be ignored and rejected.
- 1.12 All or any Claim(s), dispute(s) or difference(s) arising out of or in connection with this agreement shall be subject to the jurisdiction of the Courts at Ahmedabad only.

2. Validity of Quotation:

The offer shall be valid up to 90 (ninety) days from the end date i.e. 05.01.2024 mentioned in this NIQ for submission of quotation.

IITRAM will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest quotation for requested items:

- Notwithstanding the above, IITRAM reserves the right to accept or reject any quotation and to cancel the NIQ process and reject all quotations at any time prior to the award of contract without giving any reason.
- The bidder whose quotation is accepted will be notified of the award of contract by the IITRAM prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the Purchase Order.

5. Delivery Period & Penalty:

5.3 **Delivery:** The ordered item(s)/goods are to be delivered within a maximum time limit of 04 (four) weeks from the issue date of Purchase Order.

5.4 **Penalty:** Time allowed for completion of delivery shall be strictly followed; otherwise, the supplier shall be liable to be penalized at the rate of @0.5% of the order value for per week of delay.
