Subject: Inviting Quotation through NIQ format for Non-Comprehensive Annual Maintenance Contract for EPABX System (160 lines + 05 digital lines) installed at IITRAM – reg.

Institute of Infrastructure, Technology, Research And Management (IITRAM) invites quotation(s) for "Non-Comprehensive Annual Maintenance Contract for EPABX System (160 lines + 05 digital lines) installed at IITRAM" as per details shown in the Annexure-I on the following General Terms & Conditions:

1. GENERAL TERMS AND CONDITIONS (GTC):

- 1.1 The bidder should have valid PAN Card. Copy of PAN Card to be submitted.
- 1.2 The bidder should have valid GST Registration. Copy of GST Registration to be submitted.
- 1.3 Photo copies of filed Income Tax Returns (ITR) for the last three Financial Years (i.e. 2021-22, 2022-23 and 2023-24).
- 1.4 The bidder will have to submit duly filled & properly signed bid in the attached performa(s)/ formats and annexures.
- 1.5 The bidder shall have to submit quotation to the IITRAM office on or before 06.08.2024 till 05:00 PM in sealed envelope super-scribed "Non-Comprehensive Annual Maintenance Contract for EPABX System (160 lines + 05 digital lines) installed at IITRAM".
- 1.6 The IITRAM, Ahmedabad reserves the right at the time of purchase/ contract award to increase or decrease quantity of item(s).
- 1.7 The bidder has to quote the price for the items according to the specifications mentioned in <u>Annexure-I.</u>
- 1.8 The price quoted shall include taxes, other levy payable, all freight, packing & forwarding, transportation, loading & unloading, custom duty, excise duty & other duties, other charges (if any) to supply the item(s)/goods/ service(s) mentioned in Annexure-I at our site.
- 1.9 The contract will be initially for a period of one year which may be renewed annually for further period of two years (one year at a time) by IITRAM, Ahmedabad depending on requirement of the Institute and performance of the Contractor/ Service provider. However, IITRAM reserves the right to terminate the Contract by giving 1-month notice period if the services found unsatisfactory.
- 1.10 Material used must be as specified and other unspecified material should of good quality.
- 1.11 The bidder/ contractor(s) may visit at IITRAM, Ahmedabad for location and condition of EPBX System.
- 1.12 Wherever the Parts replacement necessitated, Call Report required to be submitted by the contractor with the tentative list of Parts to be replaced/required. Payment will be made according to the rates agreed by both parties and the rates schedule will remain valid till expiry of the CONTRACT.
- 1.13 The replaceable parts must be of standard make/quality (preferably ISI mark). Prior permission must be taken from officer in-charge of Institute (IITRAM) before replacement of any part.
- 1.14 All dismantled/ replaced spare parts to be deposited with the authorized representative of IITRAM, Ahmedabad.
- 1.15 The services related to replacement of parts/ components will remain well within the scope of AMC service provider only.

- 1.16 The successful Contractor would attend to the complaints during the normal office hours i.e. between (09:00 AM to 05:30 PM) and if necessary, beyond office hours also with the approval of IITRAM. Contractor has to solve the problem on call basis as and when required.
- 1.17 The Contractor should ensure that all the equipment included in the CONTRACT are in working condition at all time. While minor repair should be carried out within 02 hours on the same day, for the major repairs relating to the parts, the maximum permissible time period will be two (02) working days from the day of breakdown of the equipment.
- 1.18 Generally, any repair/ replacement will be done at our site. If needed, machine may be taken at your premises with prior permission of officer in-charge of IITRAM. The cost to and fro carting will be borne by yourself. Unit taken out of the office premises for the service at workshop shall be returned at the earliest & in any case, within a week time.
- 1.19 Any liability arising on IITRAM, Ahmedabad shall be deducted from the bills of the Contractor. There would be no liabilities towards the workers of the Contractor by IITRAM, Ahmedabad.
- 1.20 If there happens to be a holiday on any date indicated in this NIQ notice, the transaction shall be performed on the next working day.
- 1.21 The quotations will be opened on <u>07.08.2024</u>, <u>at 11:30 AM</u> at IITRAM Ahmedabad Premises. No separate information shall be given to individual bidders.
 - The bidders or their authorized representative may remain present during the opening of the quotations, if they desire so, at their own expenses.
- 1.22 Incomplete quotations, amendments and additions to quotations after opening or late quotations are liable to be ignored and rejected.
- 1.23 All or any Claim(s), dispute(s) or difference(s) arising out of or in connection with this agreement shall be subject to the jurisdiction of the Courts at Ahmedabad only.

2. VALIDITY OF QUOTATION:

The offer shall be valid up to 90 (ninety) days from the end date i.e. 06.08.2024 mentioned in this NIQ for submission of quotation.

• No bidder shall withdraw his rates after the quotation is opened. If a bidder does so, that bidder shall be considered ineligible for work/contract in IITRAM in future.

3. EVALUATION OF QUOTATION:

The NIQ evaluation committee of the Institute will evaluate and compare the received quotation(s) to determine the substantially responsive quotations i.e. (i) NIQ is complete (ii) properly signed (iii) confirm with the terms/conditions and specifications. Further, the financial evaluation will be made only for the substantially responsive bid based on the following parameter(s):

- Total price quoted at FB SECTION 'A' (refer ANNEXURE III).
- It is compulsory for bidders to quote their rates for both <u>SECTION 'A' and SECTION 'B'</u>. If the bidder fails to quote their price for either section, their bid will not be considered for further processing. However, the L1 bidder will be finalized who has offered lowest total price for <u>SECTION 'A'</u>.

4. AWARD OF CONTRACT:

IITRAM will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest quotation for requested item(s)/ services:

Notwithstanding the above, IITRAM reserves the right to accept or reject any quotation and to cancel
the NIQ process and reject all quotations at any time prior to the award of contract without giving any
reason.

- IITRAM reserves its right to choose, accept or reject any or all requests/deviations/offers, in full or part and also reserve the right at any stage to reduce or increase the quantity and split the order.
- The bidder whose quotation is accepted will be notified of the award of contract by the IITRAM prior to expiration of the quotation validity period. The T&Cs of the accepted offer shall be incorporated in the Work Order.
- The rates offered for components as specified in <u>SECTION 'B'</u> should be competitive in nature. The appointed committee will review the rates offered by the bidder(s) and make a decision accordingly. IITRAM reserves the right not to award the offer with components as specified in SECTION 'B'.

5. CONTRACT PERIOD & PENALTY:

- 5.1 The contract will be initially for a period of one year which may be renewed annually for further period of two years (one year at a time) by IITRAM, Ahmedabad depending on requirement of the Institute and performance of the Contractor/Service provider. However, IITRAM reserves the right to terminate the Contract by giving 1-month notice period if the services found unsatisfactory.
- 5.2 **Penalty**: If any complaint is not resolved within a week by the supplier, penalty per week @ 2% of the quarterly bill amount will be deducted from the bill.

6. TERMINATION OF CONTRACT:

6.1 Termination on expiry of the Contract

This Agreement shall be deemed to have been automatically terminated on the expiry of the CONTRACT period unless IITRAM has exercised its option to extend this CONTRACT in accordance with the provisions, if any, of this CONTRACT.

6.2 Termination on Account of Insolvency

In the event the CONTRACTOR at any time during the term of this Agreement becomes insolvent or makes a voluntary assignment of its assets for the benefit of creditors or is adjudged bankrupt, then IITRAM shall, by a notice in writing have the right to terminate this CONTRACT and all the CONTRACTOR's rights and privileges hereunder, shall stand terminated forthwith.

6.3 Termination for Unsatisfactory Performance

If IITRAM considers that the performance of the CONTRACTOR is unsatisfactory or, not up to the expected standard, IITRAM shall notify the CONTRACTOR in writing and specify in detail the cause of such dissatisfaction. IITRAM shall have the option to terminate this Agreement by giving 30 days' notice in writing to the CONTRACTOR, if CONTRACTOR fails to comply with the requisitions contained in the said written notice issued by IITRAM.

7. TERMS OF PAYMENT:

- 7.1 **Payment:** The payment will be released on quarterly basis (every three months) within 30 (thirty) working days, upon successful providing services, submission of clear tax-invoice(s) and supporting documents.
- 7.2 Advance payment will not be made under any circumstances.
- 7.3 All bills along with relevant supporting documents shall be submitted to Registrar IITRAM, Ahmedabad 380026. The original invoice (with first Invoice only) should also accompany the following documents/details:
 - a) Copy of valid Registration certificate under the GST rules.
 - b) Particulars required for making payments through Cheque/RTGS/NEFT, in accordance with the clause on 'Terms of Payment' of bid documents.
 - c) Mobile No.
 - d) e-mail ID (If any)

7.4 Recoveries as per the Institute's norms shall be made while making payment (if any) without prior intimation to the CONTRACTOR.
