### **1. General Terms and Conditions (GTC):**

- 1.1 The bidder should have valid PAN Card. Copy of PAN Card to be submitted.
- 1.2 The bidder should have valid GST Registration. Copy of GST Registration to be submitted.
- 1.3 The bidder has to quote the price for the items as per specifications mentioned in Annexure-I.
- 1.4 The price quoted shall include taxes, other levy payable, all freight, packing & forwarding, transportation, loading & unloading, custom duty, excise duty & other duties, other charges (if any) to supply the item(s)/goods/ service(s) mentioned in Annexure-I at our site.
- 1.5 The rates quoted also shall include training, installation, commissioning, erection and demonstration of items/goods/services at our site.

- 1.8 The Institute reserves the right at the time of purchase/contract award to increase or decrease quantity of items.
- 1.9 Material used must be as specified and other unspecified material should be good quality.
- 1.10 If there happens to be a holiday on any date indicated in this NIQ notice, the transaction shall be performed on the next working day.
- 1.11 The quotations will be opened on **07/01/2026, at 11:30 Hrs.** at IITRAM Ahmedabad Premises. No separate information shall be given to individual bidders.
  - The bidders or their authorized representative may remain present during the opening of the quotations, if they desire so, at their own expenses.
- 1.12 Incomplete quotations, amendments and additions to quotations after opening or late quotations are liable to be ignored and rejected.
- 1.13 All or any Claim(s), dispute(s) or difference(s) arising out of or in connection with this agreement shall be subject to the jurisdiction of the Courts at Ahmedabad only.

## **2. Validity of Quotation:**

---

The offer shall be valid up to 90 (ninety) days from the end date i.e. 05/01/2026 mentioned in this NIQ for submission of quotation.

- No bidder shall withdraw his rates after the quotation is opened. If a bidder does so, that bidder shall be considered ineligible for work/contract in IITRAM in future.

## **4. Award of Contract:**

IITRAM will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest quotation for requested items:

- 4.1 Notwithstanding the above, IITRAM reserves the right to accept or reject any quotation and to cancel the NIQ process and reject all quotations at any time prior to the award of contract without giving any reason.
- 4.2 The bidder whose quotation is accepted will be notified of the award of contract by the IITRAM prior to expiration of the quotation validity period. The T&Cs of the accepted offer shall be incorporated in the Purchase Order.

## **5 Delivery Period & Penalty Terms:**

---

- 5.1 **Delivery & Installation:** The ordered items/goods should be delivered (Including Installation, Testing & Commissioning), within a maximum time limit of 04 (four) weeks from the issue date of Purchase Order.
- 5.2 **Penalty:** Time allowed for completion of delivery and installation shall be strictly followed; otherwise, the supplier shall be liable to be penalized at the rate of @0.5% of the order value for per week of delay.

## **6 Warranty Period:**

- 6.1 Minimum 01 (one) year complete ONSITE warranty for all items from the date of successful installation of all items/goods at our site.

- 7.1 **Payment:** 100% payment shall be released within 30 (thirty) working days on satisfactorily receipt, installation and commissioning of ordered items/goods, submission of clear tax-invoice(s) and supporting documents.
