| 5 | Payment by Cheque / DD in HDFC Bank: | Students can deposit cheque / DD in accounts department with challan and collect the fees receipt after the cheque / DD is cleared. Students can also deposit cheque / DD directly to any HDFC branch by showing challan. It is mandatory to submit copy of challan stamped by bank to Accounts Department, IITRAM. Any cheque which remains(s) unrealized will attract penalty charges equivalent to non-deposition of fee. |
| 6 | Payment by online mode using Credit card/ Debit Card/ Net banking/UPI. | Students can also pay fees by UPI / NEFT / IMPS or RTGS and after payment, the receipt must be submitted to Accounts Department otherwise MIS Fee status will not be updated, and late fees will be levied as per norms. |
| 7 | Late Payment Charges | Rs. 100 per day after 15/07/2024 |

Important Note: -

- Students need to complete payment of all outstanding dues till date as well as fees for current semester on or before 25/07/2024. Payment of fees is linked with registration and students will be permitted to register for semester only after payment of fees on or before 25/07/2024. There is no provision for installment.
- It may be noted that if a student fails to pay the fees during the specified period, his/her registration for the current semester is liable to be cancelled.
- In case of nonpayment of hostel and mess fees, you may be required to vacate the hostel immediately as well as mess facility may be withdrawn without any further notice.

NOTE: - Please note that IITRAM never sends you any request for any payments including fees on any of the UPI payment applications like. Phone Pe, Google Pay, Paytm, Bhim UPI etc. **Fees payment process is solely through IITRAM MIS only.** If you receive any such request kindly block and report it immediately.
